Transline Technologies Limited (the "Company"), Amita Gupta, RKG Enterprises Private Limited (the 'Promoter Selling Shareholders') Arun Gupta HUF (the 'Promoter Group Selling Shareholder') and Rahul Jain (the 'Other Selling Shareholder') (collectively referred to as the 'Selling Shareholders') are proposing to undertake the Offer through the book building process in compliance with Regulation 6(1) of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (SEBI ICDR Regulations), at such price as may be determined by the Company in consultation with the BRLM (as defined below) and in accordance with the SEBI ICDR Regulations, Rule 19(2)(b) of the Securities Contracts (Regulation) Rules, 1957, as amended (SCRR) and other applicable laws.

The Company has filed a draft red herring prospectus dated August 07, 2025 (DRHP) with the Securities and Exchange Board of India in connection with the Offer.
